## CYCLING EVENT



*Pearisburg Lions Club Tour de Wolf Creek Bike Ride, 2024*

### RELEASE AND WAIVER OF LIABILITY

I am aware that bicycling is an athletic event which poses potentially serious risk of injuries or death to its participants. I understand that I may be injured or die as a result of my negligence, the negligence of others, or through no fault of myself or anyone else because of the nature of the activity in which I am going to be engaged. I also understand that bicycles ridden on public and private roads are often difficult to control because of road and weather conditions. With this waiver, I accept notice of the risks involved in riding bicycles on public and private roads. The waiver shall remain valid for the within named event, the Tour de Wolf Creek, on September 28, 2024, unless expressly revoked by the participant or parent or guardian of a minor, in writing, with receipt acknowledged by the Pearisburg Lions Club, the operator of the Tour de Wolf Creek. Furthermore, with this waiver, I expressly assume the risk of injury or death due to negligence by the Pearisburg Lions Club and/or Lions Club International, its agents, employees, members, officers, directors, staff, and any landowners, their families, employees or tenants over whose land I ride for my own safety or for the safety of my minor child.

With the knowledge of the foregoing, and as an inducement for the Pearisburg Lions Club to allow me to ride in the Tour de Wolf Creek, I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against the Pearisburg Lions Club, Lions Club International, or any members of its Board of Directors, employees, members, and participants, or any landowners over whose land I ride, arising from any damages, injury, or death which I might sustain. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from riding in the Tour de Wolf Creek. Furthermore, I agree to indemnify the Pearisburg Lions Club, its Board of Directors, members or employees, or any landowners, their families, employees or tenants, for any injury, death, loss or damage to any personal property which might occur during an event sponsored by the Pearisburg Lions Club or held in behalf for its benefit, when such injury, death, loss or damage occurs on the property of the land owner.

BY MAKING THIS WAIVER AND RELEASE, I UNDERSTAND THAT I AM GIVING UP (WAIVING AND RELEASING) ANY RIGHT I MIGHT HAVE TO SUE OR MAKE A CLAIM WHICH I MIGHT HAVE OR WHICH MIGHT SUBSEQUENTLY ARISE OR OCCUR AGAINST THE PEARISBURG LIONS CLUB, LIONS CLUB INTERNATIONAL, OR ITS MEMBERS AND PARTICIPANTS, OR ITS BOARD OF DIRECTORS, OR ANY LANDOWNERS, THEIR FAMILIES, EMPLOYEES OR TENANTS, OVER WHOSE LAND I RIDE, FOR ANY INJURIES I MIGHT SUSTAIN WHILE BICYCLE RIDING OR PARTICIPATING IN A BICYCLE ACTIVITY, AND THAT I AM INDEMNIFYING AND HOLDING HARMLESS, THE PEARISBURG LIONS CLUB AND LIONS CLUB INTERNATIONAL, ITS BOARDS OF DIRECTORS, MEMBERS AND EMPLOYEES, AND/OR ANY LANDOWNERS, THEIR FAMILIES, EMPLOYEES AND TENANTS, OVER WHOSE LAND I RIDE, FOR INJURING ANYONE ELSE WHILE SO ENGAGED. IT IS MY INTENT TO GIVE UP THOSE RIGHTS, AND PROVIDE THE HOLD HARMLESS AGREEMENT, AND I DO SO KNOWINGLY AND VOLUNTARILY.
